

## Shop the Show Floor at BuildingsNY 2019 Sweepstakes Official Rules

### Official Rules

#### 1. HOW TO ENTER:

(a) **"Shop the Show Floor at BuildingsNY 2019" Sweepstakes.** The sweepstakes (the "Sweepstakes") begins 12:00 AM Eastern on Friday, February 1, 2019 and ends 11:59 PM Eastern on Thursday, February 28, 2019 (the "Sweepstakes Period"). To enter, during the Sweepstakes Period, register to attend BuildingsNY (the "Show"), currently scheduled to occur April 2 – April 3, 2019 in New York, New York.

(b) **NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.** Alternatively, to enter, you should send a 3" by 5" postcard, postmarked by February 24, 2019 with your name, address, and daytime phone number to: *Shop the Show Floor at BuildingsNY 2019 Sweepstakes, Reed Exhibitions, 383 Main Avenue, Norwalk, CT 06851, Attn: Jill Giambrone*. All entries become the property of Reed Exhibitions and will not be acknowledged or returned. Incomplete entries will be considered invalid and ineligible to win. Not responsible for lost, misdirected, illegible, mistranscribed or late entries.

#### 2. GRAND PRIZE:

(a) Two (2) grand prize winners will be awarded a two hundred and fifty dollar (US\$250.00) reimbursement towards an eligible purchase placed with any exhibitor at the Show (*estimated value of grand prize is US\$500.00*).

(i) For the grand prize winners, eligible purchases require purchase order(s) dated April 2 – April 3, 2019 from purchases made at the Show.

(b) A total of one hundred (100) second place winners will each receive a ten dollar (US\$10.00) VISA gift card (*estimated value of grand prize is US\$10.00*).

(i) In order to receive their prize, the second place winners must pick up their prize onsite at the Show at such time and in such location as communicated to such second place winners by Sponsor.

(c) The two (2) grand prize winners and one hundred (100) second prize winners will be selected by random drawings at the conclusion of the Sweepstakes Period from among all eligible entries received prior to the drawing. The random drawing shall be held March 15, 2019.

(d) The drawing will be conducted by Reed Exhibitions, whose decisions are final on all matters relating to this Sweepstakes. Winners need to be present to win. Odds of winning are dependent upon the total number of eligible entries received. The winners will be notified by email, mail and/or phone by March 21, 2019.

(e) Please be aware that there may be a tax liability in accepting a prize (See Rule No. 5 below).

(f) There are no additional prizes.

**3.
