



Terms of Service

Holder's Assumption of Risk

Each Holder (individually, a "Holder" and collectively, "Holders") of a valid badge, ticket, wristband or other authorized means of entry (a "Badge") to BuildingsNY ("BuildingsNY") assumes all risk incidental to participation in all activities, loss or damage to property at BuildingsNY.

Holder's Release and Authorization

Holder hereby: (1) releases BuildingsNY, and Reed Exhibitions, a division of RELX Inc. ("Reed Exhibitions"), the Jacob K. Javits Center, their respective affiliates, employees, and agents, and such other parties as Reed Exhibitions advises as additional insureds, in its sole discretion, from any and all liability for loss or damage to persons or property, infringement of any right, or any other claims or courses of action of any kind arising from or relating to Holder's attendance of, and/or participation in, BuildingsNY; (2) authorizes and permits BuildingsNY and Reed Exhibitions and its designees, which include but are not limited to all sponsors, exhibitors and contractors, the use of his/her name, voice, likeness and all reproductions thereof by any means and in all media now and hereafter known for any and all purposes worldwide in perpetuity; (3) agrees to comply with all rules and regulations of BuildingsNY; (4) authorizes and permits BuildingsNY and Reed Exhibitions to share Holder's personal information, including but not limited to contact information, with such exhibitors, vendors, companies, and entities with which Holder scans their Badge at BuildingsNY or otherwise utilizes the on-site or web-enabled technologies, including but not limited to on-site Wi-Fi, on-site interactive kiosks, wearable beacon technology and/or RFID technology, and any mobile applications associated with BuildingsNY (the "Digital Technologies"); and (5) acknowledges and agrees that BuildingsNY and Reed Exhibitions are not responsible for lost or stolen Badges or personal property.

No Disruptive Behavior

BuildingsNY and Reed Exhibitions reserve the right to deny entry or remove from BuildingsNY any person who in their sole and absolute discretion is behaving or threatening to behave in a manner which BuildingsNY and Reed Exhibitions reasonably consider to be disruptive of BuildingsNY.

No Resale of Badge Permitted

The unauthorized resale of the Badge, attempted resale of the Badge, or unauthorized transfer of the Badge to a third-party are strictly prohibited and will constitute a forfeiture of the Badge without compensation. Each Badge may only be used by the same Holder. BuildingsNY's operating hours, schedules, vendors and speakers are subject to change or cancellation without notice. Each Badge is a revocable license to attend BuildingsNY.

All special events are subject to availability and access is not guaranteed. Special events may require an additional fee and/or will only be available to designated type of Badges.

Holder acknowledges that there are hazards and risks of physical injury or illness to attendees of special events and that not all such hazards or risks can be fully eliminated. By accepting this Badge and attending special events, Holder freely and voluntarily agrees to assume the full risk of bodily injury or property damage, regardless of severity, or death that Holder may sustain as a result of attending

special events, whether or not caused by the negligence or gross negligence of special events or Reed Exhibitions.

Individuals under 18

For industry professionals only. Anyone under the age of 18 is NOT permitted to register or allowed on the show floor. Individuals under the age of 18 must obtain the permission of a parent or legal guardian before sending any information to BuildingsNY, entering any sweepstakes or contests at BuildingsNY, posting any information on www.buildingsny.com or related websites, or purchasing any goods online related to BuildingsNY. The submission of information to BuildingsNY or the purchase and/or use of a Badge to BuildingsNY is a representation and confirmation that you are age 18 or over or have obtained the consent of a parent or legal guardian. If you are the parent or legal guardian of a BuildingsNY attendee that is under the age of 18, it is your responsibility to check the suitability of BuildingsNY for any individuals in your party regardless of official age restrictions.

BuildingsNY's Digital Technologies are neither directed at nor intended for use by individuals under the age of 13. Reed Exhibitions do not knowingly collect Personal Information from individuals under the age of 13, and if Reed Exhibitions becomes aware that it has inadvertently done so, Reed Exhibitions will promptly delete such Personal Information. If you are under the age of 13, do not access or use the Digital Technologies unless under the supervision of a parent or legal guardian, and if you are under the age of 18, do not access or use the Digital Technologies without the express consent of a parent or legal guardian.

Cancellation Policy

Registration Fees for BuildingsNY are non-refundable and non-transferable and cannot be reproduced, resold or upgraded. BuildingsNY and Reed Exhibitions reserve the right to cancel BuildingsNY on limited or no notice, and in the event of such cancellation, Holder will not be entitled to a refund for any and all expenses associated with registration.

Visual/Audio/Image Release

In exchange for the opportunity to register and attend BuildingsNY, I hereby grant to Reed Exhibitions, its employees, agents, and assignees, the absolute and irrevocable right and permission to photograph, film, reproduce, portray and/or otherwise exploit my name, voice, appearance, photograph, image and/or likeness (collectively, "Likeness") of me at Show, and to use the results and proceeds, without limitation, in materials produced by Reed Exhibitions in any and all media, in perpetuity. I hereby waive any claim to compensation for use of such Likeness. I agree that Reed Exhibitions owns the images and all rights related to them. The images may be used by Reed Exhibitions in any manner or media without notifying me, such as the BuildingsNY website, publications, promotions, broadcasts, advertisements, and posters, for advertising or other related purposes. I waive any right to inspect or approve the finished images or any printed or electronic matter that may be used with them.

I release Reed Exhibitions and its employees, agents, and assignees, including any firm authorized to publish and/or distribute a finished product containing material produced by Reed Exhibitions, from any claims, causes of action, damages or liability which I may ever have in connection with the use of or relating to my Likeness. I hereby waive any moral rights or "droits moral" I may have in the material produced by Reed Exhibitions and/or my Likeness.

I warrant that I am at least 18 years of age and that I have the right and authority to agree to the terms of this appearance release. I have read this release in full before agreeing to its terms. I understand its content, and I freely accept the terms.

To the extent that I am the parent or guardian of a minor or minors who will be attending the BuildingsNY with me, I hereby expressly approve and consent to this Visual/Audio/Image Release and waive all obligations and rights which I may have in connection therewith. For good and valuable consideration, I hereby guarantee that the minor or minors shall not at any time disaffirm the Visual/Audio/Image Release by reason of the minor's or minors' minority or otherwise and hereby agree to indemnify Reed Exhibitions from any loss arising from any claims made by or on behalf of the minors relating to this Visual/Audio/Image Release.

Anti-Harassment Policy
